

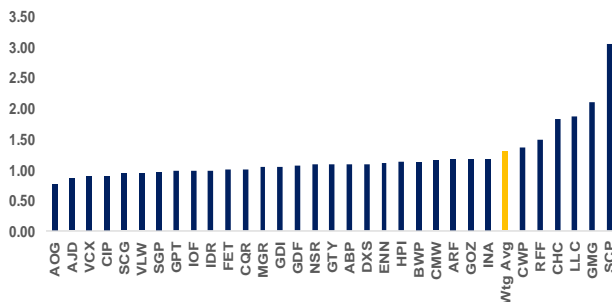

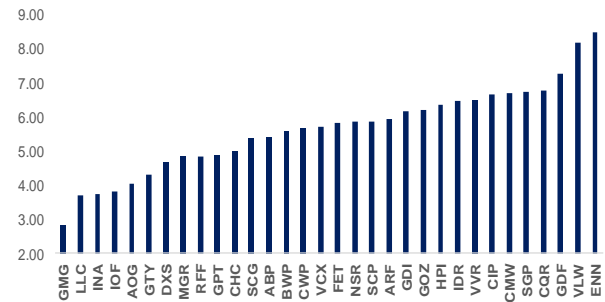

Gross Dividend Yield (%)



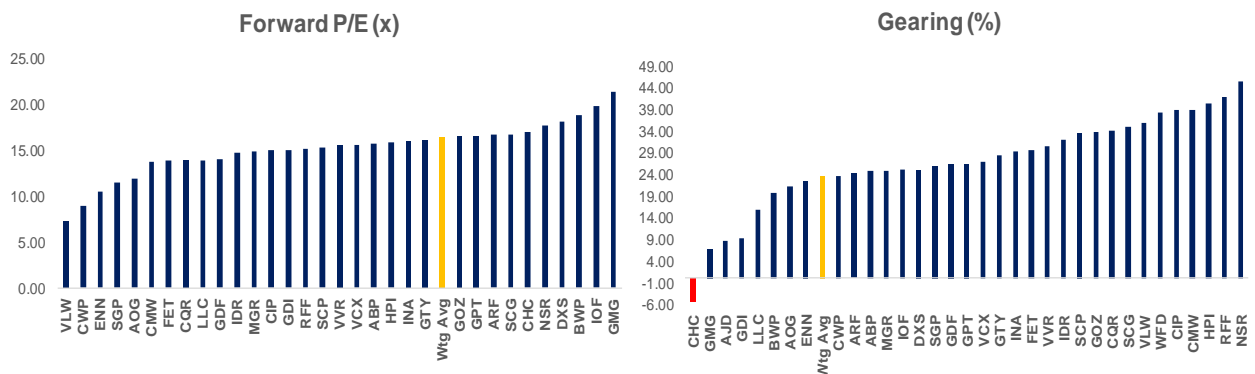
